

Exposure Checks for HealthManager

For many organizations, exposure checks are needed on regular basis and depend on rules, age, line of work, etc. The HealthManager add-on for exposure checks helps organizations to stay compliant with occupational safety and health regulations by keeping track of what upcoming exposure checks that are needed.

TAKE CARE OF YOUR TEAM AND STAY COMPLIANT

For most of our customers, especially within the EU, it is the employers' responsibility to make sure that the employees are compliant with safety and health-related regulations needed for their work. Examples of regulations that can be included in exposure checks are eyesight, hearing, health check-ups, lung function for work in dusty environments etc.

This add-on can also be used to ensure that your employees are up to date with new policies, internal regulations, code of conducts, travel policies, etc.

The add-on does not only make it easier for the organization to comply with the local and market-specific regulations for each company, but it also helps you and your line managers to take good care of your teams.

INDIVIDUAL SETUP FOR EACH CUSTOMER

Since every organization have their own needs for what exposure checks to add, the setup of the needed exposure checks, as well as the expiry period for each check, is done together with each customer. Once the correct exposure checks are setup, each employee is mapped with the needed exposures for that individual.

NOTIFICATION THROUGH HEALTHMANAGER

The Exposure Checks add-on for Aino HealthManager keeps track of what checks that need to be completed and when for each employee. When a deadline for an exposure check approaches, the line manager is notified through HealthManager to ensure that the employee has enough time to get the check and stay compliant. checks as well as start and end date for each exposure check.

When an exposure check is about to expire, a reminder is added to the managers' task list in HealthManager. To get an overview of all expiring exposure checks, the information is also available in report format. In the report, the information can be filtered on several organizational dimensions, such as department, cost center, location etc.
